



<b>Course Title: Ride on Mower (2080)</b>

**Introduction:**

LASNTG has developed this one-day course for those who work on Ride on Mowers.

**Aim of Programme:**

The aim of this programme is to provide learners with the necessary knowledge and skills to allow them to operate and maintain a ride on mower safely and efficiently.

**Target Learner:**

This training programme is for learners who will have worked with or have experience in operation and maintenance of a ride on mower. Learners can be General Operative, All Outdoor and Supervisor.

**Learning Outcomes:**

On completion of this programme, the learner will be able to:

- Describe the regulations and safety requirements relevant to the operation of ride on mowers
- Describe the characteristics and operation of the common types of cutting, discharge and collection mechanisms.
- Safely and efficiently carry out pre-start, daily, weekly and periodic checks and maintenance of the ride on mower.
- Safely and efficiently set up, adjust and operate the ride on mower.

**Assessment:**

There is a **Theory** based examination which is a Classroom Exam and Standard Pass is 70% and the duration is 20 minutes.

Also, a **Skills** demonstration with is a Site Practical Exam and has Standard Pass of 100% and this duration is 30 minutes.

**Entry requirements:**

- Applicants must be able to demonstrate a level of knowledge, skill and competence associated with Level 4 of the NFQ.
- Previous experience in working with plant and machinery is desirable
- Good colour vision and hearing

**Equipment the learner must bring to course:**

- PPE – eye protection, overalls, ear defenders, hi-vis jacket/vest, safety boots, gloves
