



Course Title: Road Opening and Reinstatement – Advanced (7219)	
Duration: 1 Day	Certification: LASNTG Certification
Expiry Period: 5 Years	Award: Assessment Certificate

Aim of Programme:

The aim of this programme is to provide the participants with the required knowledge, skills and expertise to act as the Approved Certifier/Local Authority Inspector in accordance with the Guidelines for Managing Openings in Public Roads.

Target Learner:

This training programme is for learners who will have worked with or have experience in Road Opening and Reinstatement – Advanced. Learners can be General Operative, Technician, Engineer or a Supervisor.

Learning Outcomes:

On completion of this programme, the learner will be able to:

- Demonstrate an understanding of the requirements for the role of the Approved Certifier and the roles of the various parties under the Guidelines.
- Demonstrate an understanding of the licensing process and the role of the Approved Certifier in the process.
- Identify and measure common surfacing and back fill materials used in the works.
- Carry out site inspections to check if the works are in compliance with the licence.
- Communicate any instances of Non-Compliance to the Licence Holder and recommend the appropriate Corrective Actions.
- Use the MRL System to complete licence sign off at T5 Stage.

Assessment:

There is a **Theory** based examination which is a Classroom Exam and Standard Pass is 70% and the duration is 40 minutes.

Entry requirements:

- Applicants must be able to demonstrate a level of knowledge, skill and competence associated with Level 4 of the NFQ.
- An appropriate level of Education, Training and Experience.
- Learner must have successfully completed the Basic Road Opening and Reinstatement Course.
- Excellent literacy, numerical and computer skills are essential
- Ability to interpret technical specifications, maps and drawings
- Ability to create and maintain works records
- Ability to upload information to the MapRoad Roadworks Licencing System
- Knowledge of the relevant guidelines and standards including the DTTAS Guidelines for Managing Openings in Public Roads
- Ability to identify, categorise and measure defects as set out in the Guidelines
- Ability to identify the construction and road making materials and surfaces referred to in the Guidelines
- Ability to compute areas and volumes of construction and road making materials and surfaces.
- Previous experience (minimum 2 years) working on roadworks is essential.
- Must satisfy Health and Safety requirements for working on a public road.
