Aim of Programme:

The aim of this programme is to update existing CSCS - Signing Lighting and Guarding at Roadworks Cardholders knowledge on signing, lighting and guarding at roadworks, as specified in

- Chapter 8 of the Traffic Signs Manual
- Temporary Traffic Management Operations Guidance
- HSA Guidelines for Working on Roads

This course is **NOT** a requirement for the renewal of the CSCS SLG Card. The Card is renewed as per the standard CSCS renewal process.

Target Learner:

This training programme is for learners who will have worked with or have experience in sign lighting and guarding. Learners can be Existing CSCS SLG Cardholders.

Learning Outcomes:

On completion of this programme, the learner will be able to:

- Understand the importance of keeping knowledge up to date.
- Understand how temporary traffic management relates to the site safety management system and list the responsibilities of the relevant duty holders.
- Categories roadworks in accordance with Road Type and Works Type.
- Identify and classify the equipment used in temporary traffic management, and know the rules for their use.
- Plan out roadworks sites in accordance with their site documentation, and know the scope of application for different traffic control methods.
- Operate a traffic control method in accordance with it's scope.
- List the controls required for semi-static operations and undertake the operation.
- Undertake traffic management checks.
- Complete site records.
- Assess the requirements for vulnerable road users in accordance with their site documentation.
- Undertake a structured risk assessment.
- Follow a safe system of work for a roadworks site.

Assessment:

There are currently no assessments required to complete this course.

Entry requirements:

- Applicants must be able to demonstrate a level of knowledge, skill and competence associated with Level 4 of the NFQ.
- Learners must hold a valid CSCS SLG Operator Card
- Learners must have experience of erecting, modifying and removing temporary traffic management on public roads

• Valid CSCS SLG Operator Card
